## About The NCS™

The National Community Survey  $\mathbb{M}$  (The NCS  $\mathbb{M}$ ) report is about the "livability" of Sedona. A livable community is a place that is not simply habitable, but that is desirable. It is not only where people do live, but where they want to live. The survey was developed by the experts from National Research Center at Polco.

Great communities are partnerships of the government, private sector, community-based organizations and residents, all geographically connected. The NCS captures residents' opinions considering ten central facets of a community:

- Economy
- Mobility
- Community Design
- Utilities
- Safety
- Natural Environment
- Parks and Recreation
- Health and Wellness
- · Education, Arts, and Culture
- Inclusivity and Engagement

The report provides the opinions of a representative sample of 551 residents of the City of Sedona collected from September 9, 2024 to October 28, 2024. The margin of error around any reported percentage is 4% for all respondents and the response rate for the 2024 survey was 20%. Survey results were weighted so that the demographic profile of respondents was representative of the demographic profile of adults in Sedona.



#### How the results are reported

For the most part, the percentages presented in the following tabs represent the "percent positive." Most commonly, the percent positive is the combination of the top two most positive response options (i.e., excellent/good, very safe/somewhat safe, etc.). On many of the questions in the survey respondents may answer "don't know." The proportion of respondents giving this reply is shown in the full set of responses included in the tab "Complete data." However, these responses have been removed from the analyses presented in most of the tabs. In other words, the tables and graphs display the responses from respondents who had an opinion about a specific item.

#### **Comparisons to benchmarks**

NRC's database of comparative resident opinion is comprised of resident perspectives gathered in surveys from over 500 communities whose residents evaluated the same kinds of topics on The National Community Survey. The comparison evaluations are from the most recent survey completed in each community in the last five years. NRC adds the latest results quickly upon survey completion, keeping the benchmark data fresh and relevant. The communities in the database represent a wide geographic and population range. In each tab, Sedona's results are noted as being "higher" than the benchmark, "lower" than the benchmark, or "similar" to the benchmark, meaning that the average rating given by Sedona residents is statistically similar to or different (greater or lesser) than the benchmark. Being rated as "higher" or "lower" than the benchmark means that Sedona's average rating for a particular item was more than 10 points different than the benchmark. If a rating was "much higher" or "much lower," then Sedona's average rating was more than 20 points different when compared to the benchmark.

#### **Trends over time**

Trend data for Sedona represent important comparison data and should be examined for improvements or declines.<sup>1</sup> Deviations from stable trends over time represent opportunities for understanding how local policies, programs, or public information may have affected residents' opinions. Changes between survey years have been noted with an arrow and the percent difference. If the difference is greater than 6 percentage points between the 2022 and 2024 surveys, the change is statistically significant.

1. In 2020, The NCS survey was updated to include new and refreshed items. Consequently, some of the trends may be impacted due to wording modifications that could have potentially altered the meaning of the item for the respondent.



## **Methods**

#### **Selecting survey recipients**

All households within the City of Sedona were eligible to participate in the survey. A list of all households within the zip codes serving Sedona was purchased from Polco's mailing vendor, Go-Dog Direct, based on updated listings from the United States Postal Service. Since some of the zip codes that serve the City of Sedona households may also serve addresses that lie outside of the community, the exact geographic location of each housing unit was compared to community boundaries using the most current municipal boundary file. Addresses located outside of the City of Sedona boundaries were removed from the list of potential households to survey. From that list, addresses were randomly selected as survey recipients, with multi-family housing units (defined as those with a unit number) sampled at a rate of 5:3 compared to single family housing units.

An individual within each household was randomly selected using the "birthday method". The birthday method selects a person within the household by asking the "person who most recently had a birthday" to complete the questionnaire. The underlying assumption in this method is that day of birth has no relationship to the way people respond to surveys. This instruction was contained in the introduction of the survey.

#### **Conducting the survey**

The 3,000 randomly selected households received mailings beginning on September 9, 2024 and data collection for the survey remained open for 8 weeks. The first mailing was a postcard inviting the household to participate in the survey. The next mailing contained a cover letter with instructions, the survey questionnaire, and a postage-paid return envelope. All mailings included a web link to give residents the opportunity to respond to the survey online, as well as QR codes to further encourage participation. All follow-up mailings asked those who had not completed the survey to do so, and those who had already done so to refrain from completing the survey again.

About 7% of the 3,000 mailed invitations or surveys were returned because the household address was vacant or the postal service was unable to deliver the survey as addressed. Of the remaining 2,704 households that received the invitations to participate, 551 completed the survey, providing an overall response rate of 20%. The response rate was calculated using AAPOR's response rate #2 for mailed surveys of unnamed persons.<sup>1</sup>

It is customary to describe the precision of estimates made from surveys by a "level of confidence" and accompanying "confidence interval" (or margin of error). A traditional level of confidence, and the one used here, is 95%. The 95% confidence interval can be any size and quantifies the sampling error or imprecision of the survey results because some residents' opinions are relied on to estimate all residents' opinions. The margin of error for the City of Sedona survey is no greater than plus or minus 4 percentage points around any given percent reported for all respondents (551 completed surveys).

In addition to the randomly selected "probability sample" of households, a link to an online open-participation survey was publicized by the City of Sedona. The open-participation survey was identical to the random sample survey, with two small updates; it asked a question to confirm the respondent was a resident of Sedona and also a question about where they heard about the survey. The open-participation survey was open to all city residents and became available on October 6, 2024. The survey remained open for 4 weeks. The data presented in the following tabs exclude the open participation survey data, but a tab at the end provides the complete frequency of responses to questions by the open-participation respondents.

#### Analyzing the data

Responses from mailed surveys were entered into an electronic dataset using a "key and verify" method, where all responses are entered twice and compared to each other. Any discrepancies were resolved in comparison to the

original survey form. Range checks as well as other forms of quality control were also performed. Responses from surveys completed on Polco were downloaded and merged with the mailed survey responses.

The demographics of the survey respondents were compared to those found in the 2020 Census and 2022 American Community Survey estimates for adults in the City of Sedona. The primary objective of weighting survey data is to make the survey respondents reflective of the larger population of the community. The characteristics used for weighting were age, sex, race, Hispanic origin, housing type, and housing tenure. No adjustments were made for design effects. Weights were calculated using an iterative, multiplicative raking model known as the ANES Weighting Algorithm.<sup>3</sup> The results of the weighting scheme for the probability sample are presented in the following table.

NRC aligns demographic labels with those used by the U.S. Census for reporting purposes, when possible. Some categories (e.g., age, race/Hispanic origin, housing type, and length of residency) are combined into smaller subgroups.

The survey datasets were analyzed using all or some of a combination of the Statistical Package for the Social Sciences (SPSS), R, Python and Tableau. For the most part, the percentages presented in the reports represent the "percent positive." The percent positive is the combination of the top two most positive response options (i.e., excellent/good, very safe/somewhat safe, essential/very important, etc.), or, in the case of resident behaviors/participation, the percent positive represents the proportion of respondents indicating "yes" or participating in an activity at least once a month.

On many of the questions in the survey respondents may answer "don't know." The proportion of respondents giving this reply is shown in the full set of responses included in the tab "Complete data". However, these responses have been removed from the analyses presented in the reports. In other words, the tables and graphs display the responses from respondents who had an opinion about a specific item.

#### **Study Limitations**

All public opinion research is subject to unmeasured error. While the methodologies employed for this survey were designed to minimize this error as much as possible, these other sources of potential error should be acknowledged. **Non-response error** arises when those who were selected to participate in the survey did not do so, and may have different opinions or experiences than those who did respond. **Coverage error** refers to the possibility that some respondents that should have been included in the surveyed population were not (e.g., for a general resident survey, USPS mailing lists may exclude certain types of housing units, such as multi-family buildings where mail is delivered to a common area rather than to a specific unit (though this is rare), or where mail is received at a PO box instead of the at household's physical location. Finally, **recall bias** occurs when respondents may not perfectly remember their experiences in the past year (such as participation in social or civic events), and **social desirability bias** may cause respondents to answer in ways they think cast their responses in a more favorable light.

## **Key Findings**

#### Highest-performing areas:

- Safety remains a community strength in Sedona, with multiple items scoring higher than national averages.
- Overall feeling of safety (94%)
- Feeling safe from property crime (92%)
- Feeling safe from violent crime (95%)

Several natural environment related items trended upwards by at least 8 percentage points from the 2022 survey, including:

- Preservation of natural areas (62%)
- Sedona open space (64%)
- Yard waste pick-up services (52%)

Residents praised Sedona's parks and recreation opportunities, with a few items scoring higher than the national benchmarks.

- Availability of paths and walking trails (85%)
- Recreational opportunities (81%)
- Fitness opportunities (79%)

#### Lowest-performing areas:

Affordability remains an area of concern for residents, with all related items scoring lower or much lower than national averages.

- Cost of living (10%)
- Availability of affordable quality housing (8%)
- Availability of affordable quality health care (16%)

Reviews for community design items indicate a potential area of opportunity, as many scored lower than comparison communities.

- Well-planned residential growth (25%)
- Well-planned commercial growth (23%)
- Variety of housing options (11%)
- Items related to raising children in Sedona scored much lower than national benchmarks.
- Sedona as a place to raise children (28%)
- K-12 education
- Availability of affordable quality childcare/preschool (13%)

#### Other notable results:

Most residents (85%) indicate that they would strongly or somewhat support a new crossing over Oak Creek that would provide an alternate route between State Road 89A and State Route 179.

• Around 6 in 10 respondents indicated that they would strongly or somewhat support expanding electric vehicle charging stations at retail centers, businesses, parking lots, etc.

About half of residents reported that they would like tourism to have less of a role in Sedona's economy, while a little less than half would like it to stay the same, and just 6% indicated that it should play more of a role.

#### Areas of greatest change since 2022:

Of the 123 evaluative questions included on both the 2022 and current survey iterations, 100 were statistically similar to previous results. Upward trends were seen in 21 items, while 2 ratings decreased since 2022. Changes are considered statistically significant if the 2024 rating was +/- 6% from the previous survey effort. The most significant of those trends are listed below.

#### Increases

- Economic impact on family income (+16%)
- Emergency preparedness (+11%)
- Overall opportunities for education, arts, and culture (+11%)
- Recreation programs or classes (+10%)
- Sedona open space (+9%)

#### Decreases

- Neighborliness of residents (-8%)
- Economic development (-6%)


## **Facets of livability**



Every jurisdiction must balance limited resources while meeting resident needs and striving to optimize community livability. To this end, it is helpful to know what aspects of the community are most important to residents and which they perceive as being of higher or lower quality. It is especially helpful to know when a facet of livability is considered of high importance but rated as lower quality, as this should be a top priority to address.

#### Quality and Importance by the Numbers

The table below shows the proportion of residents who rated the community facets positively for quality and the priority (importance) placed on each. Also displayed is whether local quality ratings were lower, similar, or higher than communities across the country (the national benchmark).




















