
1. Public SafetyThe Sedona Police Department patrols all areas within the City limits, serving approximately 9,900 residents and an annual visitation of 3+ million, covering 19.8 square miles. Over the past few decades, new development has been growing steadily, from new construction projects, housing and hotel developments, and increased traffic associated with tourism. The Sedona Police Department has had the same number of officers since 2009 and is considering adding new positions. Question at hand: Prioritize the highest need for public safety resources in the future: (1 being the highest rank, 3 being the lowest rank. If none of these options appeal to you, don't drag anything).


2. Transportation and Public SafetyThe need for at least seven neighborhood street connections is included in the Transportation Master Plan and will aid in emergency evacuation efforts. The City continually evaluates wildfire risk and the necessity of neighborhood street connections to aid in future emergency evacuation efforts and for better mobility. To address emergency access needs, the City is exploring building wider than normal shared-use pathways in strategic locations that only in an emergency would be available for evacuation by car. The pathways would allow pedestrian and bicycle use on a day-to-day basis.Question at hand: Recognizing the more that is allocated towards this project, the more robust and expedited the solutions will be, what level of funding would you like to allocate to street connections?


3. Transportation A prominent goal of the 10-year Community Plan is to improve circulation. The Transportation Master Plan outlined various opportunities to improve traffic circulation, resident commutes and evacuation planning, including new roadway options to connect West Sedona (89A) to South Sedona (179). There are several locations for a new route that could be located within or outside of the City limits that cross Oak Creek, linking the west and south regions of the Sedona area. To build an alternate route over Oak Creek the City will need to work with regional partners to accomplish this goal. An average estimate for the entire cost of the alternate route project is approximately \$20 million, but could be more depending on the location, length of the route connection and complexity of the project. Question at hand:Recognizing the more that is allocated towards this project, the more robust and expedited the solutions will be, what level of funding would you like to allocate to the development of an alternate route?



4. Property Acquisition City Council has directed staff to begin the planning process and purchase of property and/or property access along Oak Creek for a Creek Walk. A Creek Walk could increase opportunities for outdoor recreation, education and watershed protection. A Creek Walk would include a pathway for non-motorized recreation along Oak Creek. Access to the area would be limited to the pathway and restricted from the creek water. The Creek Walk is anticipated to extend from northern Uptown to near the Gallery Row area. To build a Creek Walk, properties and/or property access would need to be purchased. In the current fiscal year 2025, we are planning to spend approximately \$1,000,000 for the property closest to Gallery Row. The price estimates below will depend on the complexity of the project. Question at hand:Recognizing the more that is allocated towards this project, the more robust and expedited the solutions will be, what level of funding would you like to allocate to the development of a Creek Walk, in addition to what is already allocated?

5. Property Acquisition A prominent goal of the 10-year Community Plan is to increase affordable housing. According to the 2021 Sedona Housing Study, the City has a deficit of 1,620 housing units. One of the City's strategies is to acquire land in order to partner with housing developers to construct workforce housing. ResponselD Response 127 As we have seen in the past, improving infrastructure to accommodate more visitors has not solved congestion. Likewise, adding more amenities such as a creekwalk will increase visitation, esp transients seeking a place to camp. As a community, we need to consider measures to limit the number of visitors during peak periods to reduce peak congestion and maintain a decent quality of life for residents and visitors who have reserved nightly lodging. 134 I support neighborhood connections, but not as shared use paths as outlined. I would like to see roads connecting neighborhoods so primarily residents can use these to avoid 89A/179 traffic to navigate thru town 137 The community plan referred to the annexation of the Dells, which the city is pursuing, but it also referenced the master planning of the Dells, which I think should be put on the cities to do list so it can think through the future of that land and perhaps that can solve some of the discontent from folks that once the old Cultural Park amphitheater rebuilt rather than looking at a more practical solution on flat land like the Dells.
